

Year-to-date Expenses




Please pay your dues!

Winter Preparation

Advice from your local Fire Department

Days are getting shorter and colder and winter is just around the corner. Unfortunately, the city of Baltimore experiences a lot of fires in winter, and the main reason is faulty furnaces and space heaters. Your Fire Department suggests that you take some precautions to keep your family, home, and property safe. Here's a check list of things to do before you fire up your furnace and use your fire place:

- ☐ Remove clutter at least 36" away from furnaces and space heaters.
- □ Don't store any flammable material near the furnace or the fire place.
- ☐ Have your furnace checked, change out the air filter and keep fireplace flues clean.
- ☐ Check all of your smoke detectors at least twice a year (i.e., Christmas and July 4th).
- Ideally upgrade to a digital smoke and carbonmonoxide detector.
- ☐ Remove gas from mowers before storage.
- ☐ Get a fire extinguisher.

Do your children know E.D.I.T.H.?

Do you have an escape plan in case of fire? Once a fire has started in your home, it's too late to plan how to get out. Escape plans save lives! That's where E.D.I.T.H. comes in: Exit Drill In The Home. If you don't have one yet, now is a good time to sit down with your family and create a step-by-step plan.

Here is some guidance:

- ☐ Draw a floor plan of your home; show two ways out of every room. The escape routes must be known by all of the members in your home.
- ☐ Agree on a meeting place outside the home; this allows you to count heads and inform your fire department if anyone is missing.
- Practice your escape plan often! And make your
 E.D.I.T.H. realistic and pretend that some exits are blocked.
- ☐ Make sure everyone knows how to unlock all doors and windows quickly, especially in the dark.
- □ Teach your children to test doors before opening them. Touch the door with the back of your hand. If you feel any warmth, use another escape route. If the door feels cool, open it with caution. Open it slowly, but be ready to slam it shut if there is smoke and flames on the other side.
- ☐ If you are trapped, close all doors between you and the fire. Stuff the cracks around the doors to keep the smoke out. Wait at a window and signal for help. If there is a phone in the room, call your fire department and report exactly where you are.
- Remember: smoke and heat rise and smoke contains deadly gases. So during a fire, cleaner air is near the floor.
- □ **Never** go back inside until firefighters approve it.



Traffic Calming

Plans for crosswalks and islands on Argonne move forward

Friendships, neighborhood events, and other community get-togethers often bring together Original Northwood residents from opposite sides of Argonne Drive. The neighborhood's beauty and relative compactness make walking an attractive option, but crossing Argonne can be difficult. Its wide lanes and status as a thoroughfare produce fast-moving traffic which, and limited visibility, lack of stoplights, marked pedestrian lanes, and cut curbs combine to make it dangerous to cross, particularly at busy times of the day and to those in wheelchairs or with strollers.

In response to a formal proposal written by ON residents and delivered to Councilwoman Mary Pat Clarke, the city is moving forward with a plan to install two traffic calming islands with crosswalks and cut curbs to facilitate stroller and wheelchair access. The first island will be placed just west of Deepwood Road, and the second east of Westview or possibly east of Roundhill, with exact locations to be determined. Progress has been steady, and if all goes according to plan, these islands and crosswalks should be completed in the first half of 2013. Homestead Tax Credit

The short: you need to apply for the Homestead Tax Credit, and you have a little over a month to do it. Not doing so could cost you thousands in property taxes, yet **37% of Original Northwood homes** have not submitted applications.

The long (adapted from an article by Councilwoman Mary Pat Clarke): Five years ago, the Maryland General Assembly required that all Maryland homeowners apply to continue receiving the State's Homestead Tax Credit. This action was taken to "weed out" recipients' illegally claiming investment properties or second homes as eligible for this credit.

The purpose of the Homestead Credit Program is to help homeowners afford annual property tax increases on their owner-occupied homes. The State caps annual assessment increases at 10 percent as applied to annual property taxes. Baltimore City caps at 4 percent. This credit protects homeowners, regardless of age, income, or property value, from annually spiking tax bills.

Applications must be postmarked by December 31, 2012, or homeowners will lose this Homestead credit for the tax year beginning on July 1, 2013.

Councilwoman Mary Pat Clarke has long been involved with the Homestead Tax Credit issue.
