Maintenance Report

We might think that with the onset of Fall and Winter, it's the time of the year for projects around the house to end. However, there are many things to think about just as we do in preparation for the Spring and Summer.

There's some controversy about leaf raking and whether or not to rake. There's no need to rake your lawn free and clear of leaves. Leaves will add nutrients to the soil. If you can, mulch leaves with a lawn mower. Rake leaves into the flower beds to act as insulation and fertilizer for your plants and shrubs.

It is however important to keep the sidewalks, alleys, and roads clear of leaves. One of your neighbors could slip on wet or icy leaf debris. Make sure the storm drains in front of your home are not clogged and check your gutters after the trees are bare. You do not want your gutters to be clogged creating a potential ice dam during the winter.

Before the air begins to freeze, drain your garden hose and store it inside to prevent it from eventually becoming brittle. Shut off the water to your outside faucets. Cover your grills and bring in your patio furniture. They will last longer. If you have a chimney, now is the time to get it cleaned and checked to see if it's safe to use.

It's not too late to trim deciduous trees and shrubs.

Fall is the best time to do that. Please check the areas of your property between the sidewalk and the street curb. Blocked site lines for drivers at the street corners and curves can be dangerous if they cannot see cars coming beyond overgrown plant material. Check on those dead tree limbs too. A heavy snowfall could bring them down and cause damage.

It's best to remove your A/C units from the windows to prevent heat loss. At your local Home Depot or online, you can buy window kits to cover your interior windows with plastic to keep heat loss to a minimum. With a hair dryer, the plastic gets tight enough that it's barely noticeable. You can also buy rope caulking to use around the interior windows if plastic doesn't work for you. Now is the time of the year for the small critters to find a way inside your home. Check the foundation of your home for small holes and seal them with expanding foam. Check under the sink and behind your stove for small holes where they can get access to your living areas.

The Fall/Winter is the time of the year to have your HVAC system checked and filters changed to keep your HVAC running efficiently. Check your smoke/ carbon monoxide detectors and change the batteries.

Make sure you have your shovels handy and icemelt ready for the next snow fall. You're responsible for the sidewalk in front of your home, and if you are near a Salt Box, call 311 to have it refilled.

Being property owners comes with a lot of responsibilities. Keeping your belongings, your home and your yard in good condition not only benefits you, but your neighbors as well.

Covenant Winter, 2019

As the sky turns gray and the winter winds begin to blow, I can imagine that many neighbors are taking stock of projects that they want to tackle when warm weather returns. Whether that be painting exterior doors or trim, replacing old gutters, replacing a roof, or replacing drafty windows, it is important to remember that Original Northwood is part of a covenant community governed by the rules and regulations as detailed in our covenant deed documents.

When we purchased our homes, we agreed to abide by these covenants as the guide to the exterior alterations and land use in our neighborhood. Covenants are set in place to assure that properties are used and maintained at a certain standard. This ensures the integrity of the development's aesthetics and that property values are maintained.

Our neighborhood is beautiful and

was added to the National Register of Historic Places in 1998 and featured in This Old House and Baltimore Magazine. We encourage every neighbor to do all that they can to improve their properties. This document details the process for approval by the Covenant Committee and offers guidelines on the interpretation of the covenants as they apply to exterior alteration and land use. 2020 Census

Participating in the census is required by law, even if you recently completed another survey from the Census Bureau.

A complete and accurate count is critical for you and your community, because the results of the 2020 Census will affect community funding, congressional representation, and more.

By April 1, 2020, every home will receive an invitation to participate in the 2020 Census. You will have three options for responding:

- Online
- By phone
- By mail

The 2020 Census marks the first time you'll have the option to respond online. You can even respond on your mobile device.

Who Is Required To Respond? Everyone living in the 50 states, District of Columbia, and five U.S. territories (Puerto Rico, American Samoa, the Commonwealth of the Northern Mariana Islands, Guam, and the U.S. Virgin Islands) is required by law to be counted in the 2020 Census.

What Happens to Your Answers? Your personal information is kept confidential. The Census Bureau is bound by federal law to protect your information, and your data is used only for statistical purposes.

During the 2020 Census collection, you will never be asked for certain information including:

- Your Social Security number
- Money or donations
- Anything on behalf of a political party
- Your bank or credit card account numbers

If someone claiming to be from the Census Bureau contacts you via email or phone and asks you for one of these these things, it's a scam, and you should not cooperate.

Safety Report

Once again it's the season of gift giving and thieves are ready to take advantage. We all know that packages are stolen 12 months a year, but this time of year can be a particularly active period for porch pirates. Here are a few tips for making sure you have a happy holiday season:

Send deliveries to your office:

This is not an option for everyone, but if it is possible consider having companies, relatives, and associates direct deliveries to your work. Use an Amazon locker:

For Amazon customers, there are several locations—including Safeway (Harford Rd & Charles St) and Shoppers (The Alameda) - near Original Northwood where you can have your package delivered. Please note: locker availability may be limited by usage and size of package.

Leave special instructions:

In some situations, delivery services will allow you to leave special instructions for how you would like to have you packages handled (e.g. delivery to side porch).

Ask a neighbor:

Consider telling your neighbors to pick up or keep an eye on your deliveries. In the best case, consider giving neighbors permission to move or secure any package sitting out in the open.

Be a neighbor:

If you spot a neighbor's package in an exposed location, there are a number of steps you can take to protect it. Depending on your cont'd (pg. 6)

Northwood Commons

In a much anticipated update, I am excited to share news that the developers have shared with leaders of our communities. Lidl (www. lidl.com/) has signed on to the project at Northwood Commons. This means that we will have an affordably priced and high quality grocer within easy walking distance to our community.

Additionally, I have a timeline of activity at the center from developer Mark Renbaum. There had been concern raised by neighbors and championed by community leaders and Councilman Dorsey regarding rat abatement at the center prior to demolition. We have been told that there will be a certificate of abatement prior to demolition.

Our schedule for Phase 1 Demolition (above-ground before we have erosion and sediment control permit) is as follows:

- 12/4/19 Contracts signed
- 12/11/19 Phase 1 demolition mobilization begins with fencing to be installed around the shopping center
- 12/16/19 Pre-Abatement Phase 1 demolition begins (+/- 1 week)
- 12/23/19 Abatement & Rodent Extermination begins (+/- 6 weeks)
- 2/3/20 Phase 1 Building Demolition begins (+/- 10 weeks)
- 4/15/20 Phase 1 Building Demolition Complete

The erosion and sediment control permit is anticipated in May 2020, which will enable us to begin Phase 2 Demolition (below slab/grade), and then we will commence site work.

You must submit an Application for Exterior Alterations and be approved by the Committee and Board prior to proceeding with any exterior alterations. The Application for Exterior Alterations is also available on the ONA website www.originalnorthwood.org.

level of comfort or rapport, you should consider notifying them (via email, text, or social media), securing the package, or moving it to a less conspicuous location.

Be vigilant:

During the holidays, packages from friends and relatives often arrive without warning. Check your front door or delivery location more often than usual—just in case you get a surprise gift. Also, keep an eye on what is happening outside your door—in particular when delivery services (UPS, FedEx) are in the neighborhood.

I also encourage you to pay your mandatory GNCA annual assessments. These are vital for the continuing support that the ONA provides to the neighborhood. This support takes many different forms, including: several social events throughout the year, maintenance of common neighborhood areas (e.g. sign garden), financing the publication of newsletters and other informative flyers, paying for the maintenance and registration of the Original Northwood website. In addition, the funds have been used for special projects such as tree plantings and neighborhood sign maintenance. NONE of these are possible without your support.

With that said, I'd like to just expand a little to define what it means to volunteer. Volunteers are individuals who offer their expertise, knowledge, talents and services willingly, without money paid for their time or work or their service.

Volunteers that step up and choose to offer their knowledge and usefulness should be comended. Volunteering requires a lot of hard work, time, and energy and unfortunately, there are situations where volunteers are treated with disrespect.
