## MAINTENANCE UPDATE

We scoured the Internet for tips to prepare your home and garden for the warm weather that is on its way. If you have tips that you'd like to share, please reach out to us at <a href="maintenance@originalnorthwood.org">maintenance@originalnorthwood.org</a>.

#### Get your home ready ...

- Check your fire alarms, CO2 detectors, and home security systems at the start of each season.
- Clean your windows thoroughly once a season. This will keep them in operational condition and protect any UV or sun blocking capabilities. Make sure to repair/replace broken hardware or damaged screens. As an added bonus, they make looking out that much more pleasant!
- Clean your drains ... inside and out! Check your garbage disposal and clean out any leftover debris. Check your outdoor drains in window wells, basement stairways, and patios. This will prevent standing water to help keep mosquitos at bay this season.

#### Taking care of your garden ...

- Summer is a wonderful time to grow things outdoors. Whether you grow flowers, shrubs, or vegetables, getting your hands dirty can be very satisfying. If you are adding new flowers and shrubs, please consider native plants that are drought resistant, habitat helpers, and pollution reducers. - Remember our winged friends (and their good friends the squirrels). Be sure to keep bird baths clean and filled and bird and squirrel feeders well stocked. More information on backyard birding can be found here: https://tinyurl.com/k8xh8xb2.

- Clean your gutters this may require a professional. Removing debris, unclogging downspouts, and replacing/repairing damaged gutters ensures water moves away from your house. This will prevent roof, wall, and foundation damage!
- Remember, it's easier to keep your home cool if you keep the sunshine out. Consider room darkening window treatments to block the hot sun. If you can't cover a window, consider closing a door to keep the rest of your home cool!

# Crime Plan from the Baltimore Police Department

The Baltimore Police Department (BPD), in response to a request from the City Council, provided a Short Term Crime Plan for Baltimore City. Below is an excerpt from an email describing that plan. More information may be found at: https://tinyurl.com/2p9fzrm3.

The Short Term Plan focuses on 1) enhanced visibility patrols, foot patrols, and business checks in high crime areas; 2) expanded warrant apprehension efforts to target repeat violent offenders; and 3) strong participation from federal and state partners on enforcement and investigative efforts.

#### **Enhanced Visibility Patrols.**

- With additional state funding (\$8 million), BPD is enhancing their deployments, while dedicating a portion of this funding for short-term increased visibility in areas downtown and across the city. Each District has developed a dedicated summer strategy that will provide additional visibility resources that are tailored to community needs.
- ✓ The planned budget allows 300 hours of overtime for each district June September to allow focus on ensuring a continuous presence and enhancing public safety.

#### **Enhanced Warrant Apprehension**

- Additional state funding (\$3.25 million) allows BPD to significantly increase capacity for warrant roundup efforts during the summer and fall months.
- ✔ BPD will continue ongoing partnership with Baltimore City School Police, Baltimore Sheriff's Office, and U.S. Marshalls.

#### **Strong Partnerships**

- Collaboration with Federal partners will continue investigation of violent drug organizations to impact high crime areas and disrupt, dismantle, and eradicate areas of illegal drug activity.
- ✓ The plan will eliminate the most violent drug trafficking organizations, combate firearms-related and drug-related crime, and apprehend violent offenders in a timely manner.

#### Stay connected

# Biannual Community Housing Inspections

In years past, the board conducted housing inspections using a team of neighborhood volunteers. These inspections focused on items related to the condition of properties that violated Baltimore's housing code. At a recent board meeting, the president of the Northeast Community Organization (NECO) explained that her neighborhood had twice yearly walking inspections with staff from the Baltimore City Department of Housing & Community Development. Original Northwood will begin having similar inspections. The first one will take place on Thursday, June 16. The maintenance chair will walk the community with the assistant superintendent of code enforcement, and properties that violate housing codes will receive citations. The goal of these twice yearly inspections is to ensure that homeowners are maintaining properties in accordance with Baltimore housing codes. Moving forward, the maintenance chair will work with the Housing office to schedule the inspections in the spring and fall.

# Covenant Report

It has been a busy 9 months since taking over as your Covenant Chair, and my committee and I have been busy. In the last three months, we have:

- Reviewed 17 applications for exterior alterations, with all being approved.
- Continued working with neighbors whose homes were damaged in storms of last year to ensure that their projects were expedited for approval and that their contractors had the support needed to quickly get our neighbors back into their homes.

Of those approved applications:

- 50% were on Argonne, 25% on Southview, and the remaining applications coming from Deepwood and Havenwood.
- 50% included hardscaping improvements, such as fencing, decking, and retaining walls.
- 25% included door replacement or improvement.

## **Application Reminder**

As our attention turns outdoors, many of us may be planning changes to the exteriors of our homes. Please remember that we are a covenant community. What does that mean? It means that the Agreement and Deed attached to each of our homes has specific requirements by which we all must abide. One of these requirements has to do with the review and approval by the Board of all exterior alterations.

Our Covenant Chair, Lauren Bambusch, and the Covenant Committee work diligently to review applications and make recommendations to the Board. #### Covenant Violations and Enforcement

A major responsibility of the Board is to enforce the Agreement and Deed, especially with regard to the review and approval process for all exterior alterations. Our process, when notified of a potential violation, is to contact the current owner with a cease and desist letter. If the work is already completed, we send a letter of notice of the violation with a request for Application for Exterior Alterations within 30 days. Failing to receive a timely response, we reserve the right to take legal action.

There are currently 10 homes in Original Northwood that are undergoing the violation abatement process. This can become a lengthy process which can end in legal proceedings. I thank Richard Skolasky, President of the Original Northwood Association and trustee of the Greater Northwood Covenant Association, as well as Mary Stevenson, previous Covenant Chair and member of the Covenant Committee, for their continued support in assessing the outstanding violations and providing historical input in each case. In the past three months, we have been able to make significant progress in curing these violations, with one homeowner completing work to cure a violation and exit the abatement process, and several more to be completed in the next few months.
