It has been more than one year since the novel coronavirus outbreak spread to the global pandemic COVID-19. With public health



measures, emergency authorization of vaccines, and improved medical care, it appears as though we are turning a corner. Hopefully, as time progresses, work, school, and social lives will come back to a semblance of normalcy.

Also on display this spring are the many steps that the Board of Governors and Original Northwood Association have taken to attend to the safety and maintenance needs of our neighborhood. To address traffic safety on Argonne Drive, our Safety Chair Joe Mertz worked with our elected officials Ryan Dorsey and Odette Ramos and the Department of Transportation to add stripping and flexible posts to create visual barriers and slow traffic speed around our crosswalks. This work was supported by the incredible support of neighbors showing how much we can accomplish when we work together. Many of you have noticed the removal of old growth trees over the past few years. To preserve our beloved tree canopy, our Maintenance Chair Zhan Caplan worked with neighbor Jayne Mauric and Baltimore Tree Trust to plant 42 trees throughout the neighborhood. Again, this was strongly supported by neighbors! Our Social Chair Jason Drennan, with help from Lynnette Dodson, kept the food trucks rolling and re-launched our Annual Wine and Cheese. Finally, neighbors organized a Garden Walk through our lovely neighborhood.

As a volunteer organization of neighbors, the Board of Governors and Original Northwood Association strive to be inclusive and welcoming to all of our neighbors. I want to encourage everyone to be informed and involved: please join us for open sessions of our Monthly Board and Quarterly meetings, visit our website and read through the public posting of meeting minutes and financial reports. This fall, we will be holding elections for the Board of Governors. I encourage each of you to read through the list of positions and responsibilities for Board members. This is a great opportunity to have an impact on our community.

Maintenance Report: Updates

One of the most unique features of Original Northwood is our beautiful landscape. Throughout the spring and summer, projects continue in order to maintain the landscape that makes our neighborhood such a desirable place to live and visit.

- Fall tree planting Early in the Spring, Maintenance chair, Zhan Caplan and representatives from the Baltimore Tree Trust successfully planted 42 new street trees around the community. This is an important ongoing project that will help support the City's goal https:// bcrp.baltimorecity.gov/forestry/treebaltimore/canopy.
- Tree trimming and removal. Neighbors have diligently organized the removal of dead and decaying trees from property in order to ensure safety, and the Maintenance Chair appreciates such effort!
- Dumpster Days Continue: Spring cleaning sometimes requires dumpsters for larger items.

On August 14th, from 9-12, residents are welcome to bring large items to fill the dumpster that will be on Havenwood and Kelway.

More details to follow, but plan on getting rid of the things that have been gathering dust all winter! Be on the lookout for updates on Nextdoor as we get closer, but, due to limited resources caused by the pandemic, the city will not guarantee the time it will be delivered.

- · Common area clean ups are ongoing, but if you happen to see additional trash or debris on your walks, please pick it up to keep our neighborhood clean (and rat-free!)
- Neighborhood Volunteer Clean-up Events continue to be a success! Thanks to all who participated earlier this spring in clearing trash and debris from storm drains. The next event is scheduled for Saturday, July 10 from 10-11 am. We'll meet at the triangle garden at Roundhill/Argonne and fan out from there.

Northwood Commons Update

As anyone who uses the NextDoor App knows, there has been a great deal of recent progress in the grading and construction of the new Northwood Commons! I would like to take a moment to thank our neighbor Gunter Bruckman for his regular video updates. At the last GNCA Quarterly Meeting, we were provided with an update on the construction and commercial leasing for the space. Pads have been delivered to McDonald's, Fulton Bank, and LIDL in April 2021. These businesses will be located on the western half of the shopping center. Each company will be responsible for the construction of their respective freestanding buildings with expected opening late this year and in the early months of 2022.

The eastern portion of the center will include two rows of commercial space, a university bookstore,

and public safety building. The pad for the public safety building will be transferred to Morgan State University this spring. Construction on the northern commercial building and university bookstore will begin later this year. Leases have already been signed for Barnes and Noble, Beauty Plus, Tropical Cafe, and Lee's Nail Bar.

I encourage each of you to continue following the progress on NextDoor and to attend the GNCA and ONA meeting where we frequently receive updates from the developers.Further, if you haven't already downloaded the NextDoor App, I encourage you to do so!

Remembering The Civil Rights Battle At Northwood Theatre

Movie tickets at the Northwood Theatre cost just 90 cents back in 1963. However, only in America, Black people were not permitted to purchase seats to this neighborhood theatre.

It would take more than 8 years of picketing and nights in jail for hundreds of African-American college students and their supporters before the theatre in the Hillen neighborhood of Baltimore would drop its whites-only policy.

The Northwood Plaza management would stubbornly refuse to budge on its policy, even as other businesses in the shopping center dropped their resistance.

Eight full years after the students first took up the cause and after six days of mass protests in early Feb. 1963, students had finally broken the back of the theater's management. Jails released more than 340 well-behaved students who had been arrested for simply wanting to go the movies.

Signs were posted that "If the protesters stopped demonstrations at the Northwood Theatre, the management would allow Blacks into the movies, beginning at 1 p.m. on Friday, February 22, 1963.

This is notable history that began at the Northwood Plaza, history that will forever be a ingrained as a significant part of Baltimore's civil right s struggle.

It also reminds us how far we've come and how much more work needs to be done.

(The movie house closed in 1981.)

Covenant Process for Making Exterior Changes

When homes in Original Northwood and our surrounding neighborhoods were developed in the 1930s, an Agreement and Deed and By-Laws were attached to the property title. There are provisions in these documents that affect our communities to this day.

Mandatory assessments are attached to each property in the Greater Northwood Covenant Association (GNCA) (Article V). They were established in the 1930s at \$.30 per 100 square feet of land. The money is collected by the GNCA to support the Community Maintenance Fund. The amount that each neighborhood contributes to this fund, (minus vote proportional administrative costs), are to be returned to the neighborhood to support maintenance activities in the neighborhood. In Original Northwood, these funds have been used to support maintenance of our sign gardens, planting of trees, and address landscape issues that improve the quality of life for all neighbors.

The provision that is most often directly affects homeowners in Original Northwood provides for a review and approval of all alterations to the exterior of our properties (Sub-Division VI). When our neighborhood was developed, many of the homes were designed by renowned architect John Ahlers to incorporate the City Beautiful Movement to promote beauty in development to create moral and civic virtue among urban popula-

tions. From the time of our neighborhood's development until today, we have benefitted from a community with rolling hills, old growth trees, and houses with landscaping that incorporates the beauty of the surroundings. Throughout our organization's history, we have had an Architectural Guideline that provides important information that is community supported regarding exterior alterations. These alterations include roofing materials, windows and doors, color selection, and additions to existing structures.

When a neighbor is interested in making an exterior alteration, they are required to submit an application to the ONA Covenant Chair. The application can be found on our web-site: https://originalnorthwood.org. When received, the application is reviewed by a committee of neighbors. During the review process, the Covenant Chair may reach out to the applicant in order to gather more information or offer suggestions. Once the review has been completed, the committee makes a recommendation to the Board of Governors for discussion and final vote to approve or deny the application. Approvals are in place for six months following application, per our Agreement and Deed.

Perhaps the greatest and most difficult responsibility of the Board of Governors is the enforcement of the review and approval process. While the Agreement and Deed and Architectural Guidelines were developed by the community, it is the responsibility of members of the board to maintain and enforce them. In the event that exterior alterations are made without the review and approval process, the Board is taksed with reaching out to that neighbor to inform them of the non-compliance. Typically, this is via a cease-and-desist letter requesting that all work be stopped and that an application be submitted to the Covenant Chair. Violation letters will be sent to the neighbor and placed on the property file in PayHOA until the violation has been remedied. In those cases where these letters are ignored, the Board reserve the right to take legal action. We have used the legal avenue to great success in bringing homes into compliance with the review and approval process and the Architectural Guidelines.

Frequently, there are questions and concerns about the process of application for exterior changes to a home in Original Northwood. Members of the Board encourage homeowners to attend the Open Session of monthly ONA meetings or reach out to the Covenant Committee at covenant@originalnorthwood.org. To clarify the process and ensure that exterior alterations areundertaken in a manner which is consistent with the historic designation of the neighborhood and the architectural integrity of the homes.

Covenant Report: Architectural guideline revisions over the years

The Architectural Guidelines of the Original Northwood Association provide a standard reference for the appearance of our homes, with the goal of maintaining the quality architectural features original to our homes, which in turn maintains the value of our homes.

The Guidelines were first issued in 1993, but were revised in 1996, 2002, 2013, 2015 and 2018 to reflect changes in technology, building materials and community standards. These revisions included the

allowance for synthetic slate roofing, vinyl windows, outdoor equipment such as satellite dishes and non-wood doors and storm doors. In revising the Architectural Guidelines, the Covenant Committee and Board are always concerned with achieving a balance of quality, economy and historic compatibility. Each revision is carefully researched prior to adoption to ensure that the proposed product meet these goals. For example, the 2013 revision permitting vinyl win dows and the 2018 revision to allow

doors to be constructed of materials other than wood.

The ONA Board and Committee will continue to explore products and materials as they become available, while striving to maintain the original quality and character of our homes and property values. The abundance of quality architectural features in our homes are one of the reasons many people find our community so appealing to buy and live in.

GNCA Update Spring Summer 2021

On June 19th, the Greater Northwood Covenant Association (GNCA) held a Quarterly Meeting, Future meeting dates and times can be found on the Original Northwood website originalnorthwood.org. The GNCA is a regional neighborhood association that comprises the Original Northwood, New Northwood, Ednor Gardens, Hillen Road, Stonewood-Pentwood, and Perring-Loch communities. The GNCA holds the Agreement and Deed that conveys with each of our properties. During these meetings, Trustees from each neighborhood provide an update. A common thread has been traffic safety and parking.

As noted in the President's Corner, ONA is working hard to address traffic safety issues. While we have made some progress on Argonne Drive, we still need to have a speed camera installed. We also need to address the speed of traffic on The Alameda and Loch Raven Boulevard and on Kelsey Road. Each of these challenges will be successful with the help of neighbors and our elected officials.

Parking is another issue that, while always a challenge in a neighborhood not built to accommodate our current car culture, has become more challenging with more people working and schooling from home. With relatively few exceptions, the streets in our neighborhood are designated for public parking. From my understanding, Baltimore City statute states that cars should be parked for no more than 48 hours on public streets.

Walking through our neighborhood, I note several problematic parking issues: double-parking on narrow streets; parking in no parking areas leading to limited visibility; and parking in the wrong direction. I've also noticed that some neighbors are moving their cars in and out of the same space - effectively treating it as a private parking space and limiting availability for other neighbors.
